

# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 10 JULY 2024

## DESIGNATING A EUROPEAN DELEGATED PROSECUTOR PURSUANT TO ARTICLE 16(7) OF THE EPPO REGULATION AND ASSIGNING ADDITIONAL TASKS

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('the EPPO') (hereinafter referred to as "the EPPO Regulation"), and in particular Articles 13(2), 16(7), 17 and 96 thereof,

Having regard to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Community of Atomic Energy, hereinafter respectively referred to as "the Staff Regulations" and "the CEOS" and in particular to Article 123 of the CEOS,

Having regard to Decision 001/2020 of the College of the European Public Prosecutor's Office of 29 September 2020 laying down rules on the conditions of employment of the European Delegated Prosecutors, as subsequently amended and supplemented (hereinafter referred to as "the CEEDP"), and in particular Articles 14 to 16 thereof,

Having regard to Decision 003/2020 of the College of the European Public Prosecutor's Office of 12 October 2020 on the Internal Rules of Procedure of the EPPO (hereinafter referred to as "the Internal Rules of Procedure"), as subsequently amended and supplemented, and in particular Articles 31 and 34 thereof,

Having regard to Decision 002/2021 of the College of the European Public Prosecutor's Office of 13 January 2021 on the Financial Rules applicable to the EPPO (hereinafter "the Financial Rules"), and in particular Article 78 thereof,

Having regard to the Decision 013/2021 of the College of the European Public Prosecutor's Office of 24 February 2021 laying down rules on the tasks and rights of the European Delegated Prosecutors designated to substitute the European Prosecutor of their Member State (hereinafter "the College Decision 013/2021"),

Having regard to the Decision 030/2023 of the College of the European Public Prosecutor's Office of 24 May 2023 entering into force on 3 June 2023 and designating for a duration of one year Ms. Laura Pellón Suárez de Puga to substitute the Spanish European Prosecutor in case the latter is unable to carry out the functions or left the position pursuant to Article 16(7)



of the EPPO Regulation and assigning additional tasks to the substitute European Delegated Prosecutor during the same period of one year,

Having regard to the reasoned proposal of Mr Ignacio De Lucas Martin, European Prosecutor in Spain, of 8 July 2024, proposing to the College:

- To approve the designation for a duration of two years of Ms. Laura Pellón Suárez de Puga, to substitute the Spanish European Prosecutor in case he is unable to carry out his functions or leaves his position pursuant to Article 16(7) of the EPPO Regulation, and
- To approve the assignment for a duration of two years to Ms. Laura Pellón Suárez de Puga of the same additional tasks assigned to the substitute European Delegated Prosecutor by the College Decision 030/2023, pursuant to Article 3(2) of the College Decision 013/2021.

Has adopted this Decision:

## Article 1

### *Designation pursuant to Article 16(7) EPPO Regulation*

The College approves the designation of Ms. Laura Pellón Suárez de Puga, European Delegated Prosecutor in the Kingdom of Spain, to substitute the Spanish European Prosecutor in case he is unable to carry out his functions or leaves his position pursuant to Article 16(7) of the EPPO Regulation.

## Article 2

### *Additional Tasks*

The College approves the assignment of the additional tasks in question to Ms. Laura Pellón Suárez de Puga, European Delegated Prosecutor pursuant to Article 3(2) of the College Decision 013/2021.

## Article 3

### *Entry into force*

This decision shall enter into force on the date of its adoption by the College of the EPPO.
