



# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 4 SEPTEMBER 2024

## GRANTING THE ACTING ADMINISTRATIVE DIRECTOR OF THE EPPO A DIFFERENTIAL ALLOWANCE

The College of the European Public Prosecutor's Office ('EPPO'),

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and to the Conditions of employment of other servants of the European Union ('CEOS')<sup>1</sup>, and in particular Article 7(2) of the Staff Regulations and Article 10 of the CEOS,

Having regard to Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office (hereinafter referred to as the "EPPO Regulation")<sup>2</sup>, and in particular Article 96 thereof,

Having regard to the Internal Rules of Procedure of the EPPO<sup>3</sup>, and in particular Article 8 thereof,

Having regard to the Decision 089/2021 of the College of the EPPO of 8 September 2021 on implementing rules on temporary occupation of management posts (hereinafter referred to as the "College Decision 089/2021"), and in particular Article 4 thereof,

Having regard to the Decision 025/2024 of the College of the EPPO of 24 April 2024 for the temporary occupation of the management post of Administrative Director of the EPPO,

Considering that:

1. The circumstances of the temporary assignment of the acting Administrative Director were reassessed by the College at its meeting of 12 June 2024, and the College confirmed that the Decision 025/2024 of the College of 24 April 2024 should remain in force until the Administrative Director resumes his duties or a new Administrative Director is appointed.

2. From the beginning of the fourth month of a temporary posting, the temporary staff member concerned may receive a differential allowance equal to the difference in current remuneration of the temporary staff member and the remuneration according to the level of the temporary posting, in accordance with the provisions set out in Article 4 of the College Decision 089/2021.

Has adopted this decision:

### Article 1

From the beginning of the fourth month of the temporary posting, Ms. Kristel SIITAM-NYIRI shall receive the differential allowance in accordance with the provisions of Article 4 of the College Decision 089/2021.

### Article 2

This Decision shall take effect on the day following that of its adoption.
