

DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 20 NOVEMBER 2024

AMENDING THE DECISION 039/2024 OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 26 JUNE 2024 ON THE ADOPTION OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE BUDGET FOR THE YEAR 2024

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 1939/2017 of 12 October 2017¹, implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), hereinafter referred to as "the EPPO Regulation", and in particular Article 92 thereof,

Having regard to Decision 002/2021 of the College of the European Public Prosecutor's Office of 13 January 2021 on the Financial Rules applicable to the European Public Prosecutor's Office, as amended and supplemented by the College Decision 023/2023², hereinafter referred to as "EPPO's Financial Rules", and in particular Article 33 thereof,

Whereas:

- (1) In accordance with the EPPO Regulation, the College shall adopt the amending budget of the EPPO on a proposal from the European Chief Prosecutor,
- (2) In accordance with the EPPO's Financial Rules, an amending budget of the EPPO shall be adopted by the same procedure as the initial budget of the EPPO in accordance with the provisions of the EPPO Regulation,

Has adopted the following Decision:

Article 1

1. The European Public Prosecutor's Office amending budget No 2 for 2024, as annexed to this Decision is hereby adopted.

2. The adoption is conditional to the final adoption of the EU's 5th amending budget 2024 by the budgetary authority.

Article 2

This decision shall enter into force on the day following that of its adoption.
